## **Directions to Wolf Creek Equine Clinic**

**410-741-1473**

### **From the North / Annapolis region or Maryland's Eastern Shore:**

Take Rt. 2 South to the traffic circle in Lothian.  
From the circle, take Rt. 408 West toward Wayson's Corner and Upper Marlboro.  
Proceed 3.3 miles on Rt. 408.  
Turn right onto Fiorenza Drive.  
Go to the end of Fiorenza Drive and through our gate, #936.

### **From the North / Bowie (Rt. 301):**

Take Rt. 301.  
Exit Rt. 4 South toward Prince Frederick.  
In approximately 1 mile, exit onto Rt. 408 East toward Wayson's Corner.  
Proceed straight on Rt 408E at stoplight, and continue for 2.2 miles.  
Turn left onto Fiorenza Drive.  
Got to the end of Fiorenza Drive and through the gate, #936.

### **From the South / Southern Maryland:**

Take Rt. 4 North toward Washington, D.C.  
Exit onto Rt. 408 East toward Wayson's Corner.  
Turn left at the end of the exit ramp and proceed to the stop light.  
Turn right onto Rt. 408 East at the stoplight, and continue for 2.2 miles.  
Turn left onto Fiorenza Drive.  
Go to the end of Fiorenza Drive and through the gate, #936.

### **From the West / Washington D.C.:**

Take Rt. 4 South toward Prince Frederick.  
Exit onto Rt. 408 East toward Wayson's Corner.  
Proceed straight on Rt. 408 East at the stoplight, and continue for 2.2 miles.  
Turn left onto Fiorenza Drive.  
Go to the end of Fiorenza Drive and through the gate, #936.
